### Midyear 2022 FAQs

1. What does "delayed livestream" to Midyear mean?

Answer: Anyone who doesn't register to attend virtually on zoom via eventbrite or physically attend won't see the worship services and the Dr. Obrey Hendricks, Jr. presentation realtime.

- 2. Can the same email address be used to create multiple Midyear registrations? Answer: Yes. When registering that individual with your email address, please use their first and last name to keep each registration separate. This is extremely important for those who are attending in person. However, an email with a unique identifier for each registered person will be sent. This unique identifier email must not be given to anyone other than the registered person.
- 3. How will those who register to attend Midyear virtually access the Midyear events each day?

Answer: They will use the Zoom link with a unique identifier that was emailed with their registration confirmation each day. *This link must not be used by anyone other than the registered person.* 

4. Will those who register to attend Midyear virtually be able to have phone only access to the Zoom platform?

Answer: Yes. The email that was sent with their registration confirmation contains Zoom phone access information with a unique identifier. *This Zoom phone access information must not be used by anyone other than the registered person.* 

5. How will those who still need to complete the sexual harassment training who register to attend Midyear virtually get credit for the training?

Answer: You will be asked to put your name and email in the "chat" so that the workshop leader may take note of your attendance and the Zoom Team may elevate you to panelist status if necessary.

6. Where will in person attendees get the provided meals during the Midyear Convention?

Answer: The midday meals on Tuesday and Wednesday will be served in the dining room which will only be open to the 5th District.

7. How will the provided meals for in person attendees be served during the Midyear Convention?

Answer: Three course plated midday meals will be served on Tuesday and Wednesday.

### 8. Why are people being required to register?

Answer: In Person registration helps us make sure that we don't exceed the maximum attendance threshold related to COVID restrictions. Virtual registration helps us make sure that virtual attendees receive real time access to the conference.

# 9. What if I decide at the last minute that I want to attend in person and paid for virtual?

Answer: There will be no refunds. However, you can register for in person attendance and if there is room, you will be allowed to attend in person. Your virtual attendance will remain active.

## 10. What's the cost of parking?

Answer: Self parking is \$15 and Valet Parking \$20.

## 11. Are there any COVID Protocols to know in advance before attending in person?

Answer: (Part 1) Yes, all persons who are attending in person are mandated to provide their negative COVID test which must be taken 72 hours before arrival in Los Angeles at MidYear. This will keep us in compliance with the Hilton, city of Los Angeles, and Los Angeles County for COVID protocols. If you are unable to provide a negative COVID test within 72 hours of arriving at MidYear, having a vaccination card (1 J&J or 2 Moderna and Pfizer shots) will suffice. If you have tested positive within 21 days before arriving at the MidYear Convention, please stay home and attend virtually.

Answer: (Part 2) If attending in person, other than providing a negative COVID test from 3 days prior or your fully vaccination status card, there will be mandatory testing on Monday and Tuesday of MidYear. We thank you in advance for adhering to the safety protocols and procedures for MidYear.
